Brian Lockwood requests clarification that "City on surface water" was Santa Cruz Chris Berry moves with that modification, Paul Lego seconds Minutes approved unanimously

C. <u>PUBLIC COMMUNICATIONS</u>

Ray Perera, who will be appointed to the commission on August 10th, introduced himself

D. <u>COMMISSIONERS' REPORTS</u>

- Paul Lego met with Nathan Salazar and Sean Abbey on preparing a small water systems forum on reserve analysis planning
- Frank Cheap toured the City of Santa Cruz water facilities, was a very impressive facility. Newell dam re-piping was a highlight. It's an outstanding PR level, to explain what rates are going up.
- Lake is down around 60%, which is causing concern with predictions for an El Nino. They're in an exception year to their water rights diversions.
- The City of Santa Cruz is responding to comments on their water rights EIR.
- Brian Lockwood said that the Groundwater Resources Association of California recently held their Groundwater Sustainability Agency Summit
- AEM surveys will be happening statewide. There will be 2-mile flight lines. The State will not be in our area for some time.
- California Water Commission meeting today on water allocations and trading. Presentations about how water markets are working for groundwater for farms and ranches.
- Frank Cheap encourages commissioners to attend meetings of other water districts

F. <u>NEW BUSINESS</u>

 Presentation by Marilyn Underwood and Heather Reynolds providing an update on the Local Area Management Plan (LAMP), and possible action to provide a letter of support to the Board of Supervisors.

The presentation is available on the website.

Paul moves that the WAC endorse the LAMP, Chris Berry seconded. Passed unanimously.

G. UNFINISHED BUSINESS and UPDATES

1. Pajaro Floodplain Management – Update to the levee project, which has been ongoing since they were built in the 1940s. Recently secured a feasibility study, and directors report from the Army Corps that re-authorizing the congressional approval to move forward. Over the past 2 years the County received \$4.6 million to work on design of the project, which should cover the design phase of the first component of the project. Now working on design and simultaneously looking for implementation funds. Project includes setting back the levees in some areas and build them taller in other to increase the flood level protection. The cost share is a 65% Federal 35% local split. There is authorization for the State to cover 90% of the local share. That still leaves a gap of \$42 million to be filled locally. Trying to move forward legislation at the State that would allow coverage of the full implementation amount.

Recently formed a joint powers authority to coordinate the effort to maintain the new infrastructure, called the Pajaro Regional Flood Management Agency. The JPA includes Santa Cruz and Monterey counties, the City of Watsonville, Zone 7 flood control district of Santa Cruz County and The Monterey County Water Resources Agency. First meeting will be 9am on Sep 8th.

- 2. Pajaro Valley Groundwater Management Continuing to make progress on the GSU process, they are almost done with the 5-year update. The Board has adopted all the items that the Committee recommended so far. Have received 60% designs for infrastructure at College Lake and the Pipeline plan is at 30%.
- 3. Santa Margarita Groundwater Management The public comment period is open on the draft GSP. Sierra recommended the Commissioners particularly focus on Section 3.
- 4. Mid-County Groundwater Management
- 5. WAC Workplan Subcommittee Update
 - o Linda Wilson recommends replacing "flood water" with recharge
 - Chris Berry: Where does flood control fit in this? Are these just umbrella topics? In the original workplan there was a lot of specificity, and this allows more flexibility.
 - Paul Lego: Likes this as an umbrella. When we talk about water supply and quality, the elephant in the room may be demand. Is there a place for the BOS in there?
 - Chris Berry: Does this capture the full scope of protecting all beneficial uses of water? Does it cover recreation and habitat or more focus on municipal water supply?
 - Brian Lockwood: After we develop the list, the Commission should evaluate priorities. These can change, for example now we are in a drought.
 - Frank Cheap: Strongly agree that recreation and fish and wildlife should be included. For the average person on the street, having the County focus on drought now will be what is important to people. Intent is to have some flexibility.
 - Next Step: The subcommittee can bring this back at the next meeting after writing up some descriptions of these items.
