J. BOARD OF SUPERVISORS ACTION ON ITEMS AFFECTING WATER:

April 14, 2015 – 50. ADOPTED RESOLUTION NO. 100-2015 authorizing a grant proposal to the California Department of Conservation to develop a voluntary program - Rotational Cover Crop Plan for Pajaro Valley.

<u>May 19, 2015 - 36</u>. Authorized an amendment to the agreement that provides for County participation in the Soquel-Aptos Groundwater Management Committee (SAGMC); designated the First and Second District members of your Board to serve as the County representatives on the SAGMC

June 9, 2015 - 38. ACCEPTED AND FILED status report on drought conditions; scheduled a public hearing on June 23, 2015, to consider a proposed urgency ordinance declaring a state of drought emergency and amending Santa Cruz County Code Chapter 7.69, Water Conservation, requiring further restrictions on water use; and considered adopting in concept a proposed ordinance amending Section 7.71, Water Systems, requiring water use measurement and reporting by small water systems

<u>June 9, 2015 - 42.</u> ADOPTED the County of Santa Cruz Steelhead and Coho Salmon Conservation Strategy 2015 plan; and directed the Departments of Health Services, Public Works, Planning, Parks, Open Space and Cultural Services, and the Agricultural Commissioner's Office to implement the actions in the plan.

<u>June 23, 2015 - 31</u>. AWARDED contract to Earthworks Paving Contractors, Inc., in the amount of \$140,972 for the Brommer Park Groundwater Recharge Enhancement Project.

June 23, 2015 – 96 (1) ADOPTED ORDINANCE NO. 5206, as an urgency, amending Chapter 7.69 of the Santa Cruz County Code, Water Conservation, requiring further restrictions on water use and declaring a state of drought emergency; and (2) APPROVED "in concept" ordinance amending Section 7.71 of the Santa Cruz County Code, Water Systems, requiring water use measurement and reporting by Small Water Systems with 5 to 199 connections to return August 4, 2015, for final adoption;

August 4, 2015 - 9 Adopted ordinance amending Chapter 7.71 of the Santa Cruz County Code, Water Systems, to require water use measurement and reporting by Small Water

<u>September 29, 2015 – 42</u>. Public hearing to consider the 2016 Growth Goal, 2016 Growth Goal Report, with status of water supply.
